Introduction

Formed in 1945 with the help and advice of the Area Factory Inspectorate and The Royal Society for the Prevention of Accidents (RoSPA), the North Lincs Health and Safety Group is affiliated to both RoSPA and the British Safety Council.

Purpose of the Group

With the continuing trend towards small businesses: DTI figures show that 97% of all UK businesses employ less than 20 people and 94% of all UK businesses employ less than 10 people – makes the case for expanding the local Health & Safety Groups stronger than ever.

Local Health and Safety Groups, of which there are about 80 within the UK, are voluntary non-profit making organisations established to promote health and safety at work. They play a vital role in cascading information and advice from HSE and other relevant organisations down to local businesses. The group is a complement to and not in competition with other safety organisations and provides a forum for support with all who are concerned with occupational accident and ill-health prevention.

The Groups provide a self-help mechanism for member companies as well as a means of promoting health and safety at work by reaching out to help local businesses.

Membership

RoSPA and the British Safety Council actively encourage companies to join and support the work of the local Occupational Health and Safety Groups. All local groups are affiliated to RoSPA and the British Safety Council, which, in turn, provide support in various ways.

There are 100 or so members of the North Lincs Health and Safety Group, from the smallest (sole traders) to the largest employers in the area.

Membership is also valuable to individuals interested in Accident Prevention.

Membership is open to industrial, commercial, and other organisations as well as to individuals and costs just £85 per year: this includes 1 free place at each Group Meeting.

Meetings and events

Regular Group Meetings are held at the Wortley House Hotel, in Scunthorpe and these provide the opportunity to network with other Health and Safety Professionals to discuss developments in health and safety legislation, new initiatives from HSE and other relevant topics.

Training, in the form of seminars, demonstrations and exhibitions regularly feature in the Group's calendar, which culminates in the presentation of Annual Safety Awards, for which each member is eligible to apply, at the Annual Dinner held each February.
